AIM

To enhance the health and well-being of all Western Australians by: reducing the harms associated with alcohol and other drug use; and enabling a strong and viable alcohol and other drug service system.

PURPOSE

To lead a shared voice within the specialist alcohol and other drug service sector that drives positive change needed to achieve best community outcomes.

STRATEGIC PRIORITIES



- 1. Provide an informed voice to influence effective alcohol and other drug service planning
- 2. Advance effective approaches to minimise the impact of stigma and discrimination
- 3. Drive sector implementation of, and policy support for, the principles of self-determination
- 4. Lead a coordinated approach to sector-wide development that enhances best practice and equitable access

- Influencing policy, planning, development and implementation requires strong and respectful relationships with decision makers.
- WANADA's authority to provide an independent representative voice is founded on awareness of relevant evidence that is grounded through sector expertise.
- Stigma is a fundamental barrier to consumer outcomes. Stigma is evident in alcohol and other drug related policy, planning and implementation – which often reflects community discriminatory attitudes.
- A shared voice will contribute to community awareness of alcohol and other drug related harms and build community support for effective solutions.
- A systems-based approach to self-determination will contribute to improved health and social wellbeing outcomes for Aboriginal peoples.
- Translating the principles of self-determination into meaningful action, to achieve better outcomes, requires a sector-wide commitment supported by genuine partnerships and shared accountabilities.
- An evidence-informed approach to sector development (i.e. workforce development/capacity building) requires an appropriate focus on the individual, organisation and system.
- Sector-led solutions to data and outcomes will inform development priorities.

MEASUREMENT

- Members and stakeholders report satisfaction with, and effectiveness of, WANADA's activities (obtained through event evaluation, surveys and case studies)
- Number and type of activities, including co-design, that address stigma and discrimination and self-determination.
- Number and topic areas of WANADA-developed and supported position papers that enhance a shared sector voice (including indications of member and stakeholder endorsement).
